Sub: Submission of Revised Disclosure under Regulation 7(2) of SEBI (Prohibition of Insider Trading) Regulations, 2015

Dear Sir/Madam,

With reference to our earlier disclosure submitted on 09th March, 2026 under Regulation 7(2)(b) of the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015 ("PIT Regulations"), regarding the trading in Equity Shares of the Company by the Promoter Group, we wish to inform you that the said disclosure contained an inadvertent clerical error.

In the previously submitted disclosure, the mode of acquisition of Equity Shares was inadvertently mentioned as an off-market transaction, whereas the transaction was in fact a *Market Purchase*.

The Company has received a letter dated 10th March, 2026 from the Promoter Group requesting rectification of the said error. Accordingly, in order to correct the same, the Company is submitting herewith the revised disclosure in Form B under Regulation 7(2)(b) of the PIT Regulations.

The revised Form B correctly reflects the nature of the transaction as market purchase instead of off-market transaction. This submission is being made for the purpose of placing the corrected information on record with the stock exchanges.

Further, this disclosure is in continuation of the intimation already made on 09th March, 2026 and may kindly not be construed as a case of non-compliance under the applicable provisions of the PIT Regulations, as the revision is only to rectify an inadvertent clerical error in the earlier submission.
